Sealed proposals will be received at the offices of the Henry County Board of Commissioners until 10:00 O'clock A.M. Local Time Thursday, June 17, 2010, at which time they will be opened and read immediately thereafter for:

PROJECT DESCRIPTION: The project involves the construction of an advanced aerated facultative lagoon process with aerated rock filter, bioaugmentation, and floating cover to pre-treat leachate from the Henry County Landfill. The project consists of the installation of a recompacted clay lined Equalization lagoon and two Pre-Treatment lagoons with a total combined capacity of 2.6 million gallons, 4 pumping stations, approximately 3,300 feet of 2-4 inch forcemain, and 2,300 feet of air piping. The work also includes new catch basins, manholes, drainage tile, and related treatment process items and site work.

Drawings, Specifications, and blank bid forms may be obtained at the above office of the ENGINEER upon payment of one hundred twenty-five dollars (\$125.00) NON-REFUNDABLE. Contract Documents can be shipped for an additional \$10.00 shipping and handling fee. Contract Documents will be shipped as soon as possible after receipt of request and payment for such documents. BIDS WILL ONLY BE ACCEPTED FROM BIDDERS LISTED ON THE ENGINEER'S OFFICIAL LIST OF PLANHOLDERS. Checks shall be made payable to Feller, Finch & Associates, Inc.

A bid guarantee instrument must be submitted with the bid. The bid guarantee instrument shall be in the form of a Bid Guarantee and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code for the FULL AMOUNT of the bid OR a certified check, cashiers check, or irrevocable letter of credit for an amount equal to ten percent (10%) of the bid. The bid guarantee shall be made payable to the Henry County Board of Commissioners, and is to be held as a guarantee that in the event the bid is accepted and a contract is awarded to the BIDDER, the contract will be duly executed and its performance properly secured.

The successful BIDDER(s) shall be required to furnish a Contract Bond in accordance with Section 153.54 of the Ohio Revised Code in a sum of not less than one hundred percent (100%) of the total contract amount. The bond shall be issued by a surety company or corporation licensed in the State of Ohio to provide said surety.

All contractors and subcontractors involved with the project must use Ohio products, materials, services, and labor to the extent practicable, and pay Ohio Prevailing Wage Rates for Henry County, Ohio as determined by the Ohio Bureau of Employment Services, Wages and Hour Division. Additionally, contractor compliance with the equal opportunity requirements of the Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Each bid proposal must be made upon the blanks, or facsimiles thereof, furnished with the Contract Documents. Each proposal must contain full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of similar size and complexity. The owner intends and requires that the project be substantially completed by no later than November 24, 2010 and be finally completed by no later than December 17, 2010.

A non-mandatory Pre-Bid Meeting will be held at the Henry County Landfill Office at 10:00 am on Tuesday June 8, 2010. Representatives of the Owner and Engineer will be present to discuss the project. Bidders are encouraged to attend and participate in the meeting.

The OWNER reserves the right to reject any or all bids, to waive any informalities or irregularities in the bids received, and to accept any bid that it deems most favorable.
